

Terms of Use for MADSCAN Community Pages Registration

Please read the following Terms of Use carefully before using the Community Pages of the MADSCAN website. By registering you agree to the following terms and conditions:

1. You agree that MAD may without royalty at any time at any place use, reproduce, publish or republish, modify, adapt, translate, create derivative works from, distribute, and display, in whole or in part, and to incorporate in other works, in any form, media or technology now known or later developed any content that you post.
